## Ecological Landscape of WI: Forest Transition

The Peterson Woodland is located in Marathon County at the headwaters of the Big Sandy Creek. 40 acres of the property was purchased by Ben Peterson and his wife, Melissa, in 2016 and they purchased the adjacent 120 acres from his father, Dan, in 2024. All 160 acres of the property are currently under the Managed Forest Law Program.

In 2020, during the pandemic, Ben and his family built a home on the land and moved to the property fulltime. The Petersons wanted to provide their children the opportunity to play outdoors and learn to appreciate the land and nature as they did when they were growing up. Together the family cooperatively manages the adjacent wooded parcels for all to enjoy.

Since purchasing the property, the family has developed 7 miles of trails from old logging roads which weave through various hardwood stands and pockets of hemlock and other conifers. The trails are used by the family for hiking and UTV riding during the summer and snowshoeing and cross country skiing in the winter. With the help of their Snapshot Wisconsin trail camera through the Wisconsin Department of Natural Resources, the Petersons have discovered all kinds of wildlife within their property including porcupine, black bear, fisher, mink, raccoons, grouse, and lots of other birds.

They've witnessed four different species of woodpecker on the property, including the large Pileated woodpecker. Along with just viewing wildlife, the property is also used for hunting by Ben and his father, which is another important value they have in mind when managing the property.

With the bountiful maple trees on their property and custom sugar shack that Ben built in 2017, the Petersons spend a lot of their time collecting maple sap. Every year, they produce 15 gallons of maple syrup, which requires tons of sap! The Petersons love to share their syrup with family and friends during their pancake brunch gatherings.

Although the property hasn't been in the family long, it is already an important part of their lives and their future. They view their contribution to the land as a legacy to pass on to their children and future generations.
